CAN YOU TOP THIS?

Angler **Ken Huss**, a resident of Huntington Beach, traveled to Chatham, Mass. with wife **Janet** in October of 2009 in pursuit of a giant northern blue fin tuna. The trip had to be scheduled 9 months in advance and was booked with **Capt. Mike Abdow**. The boat was a 32-ft. commercial/sports vessel. Massachusetts rules require that the boat keeps any fish weighing over 250 lbs. and the angler keeps anything under that size. Day one of his four day charter Ken saw his line go tight with only one bite. It chewed through the flourocarbon leader and got away.

The second day his line went tight at 10 a.m. ripping 200-lb. line off his reel and pulling the boat backwards. Eventually, with the aid of a harpoon and a flying gaff they pulled the fish to the stern where it was tied off. It turned out to be a



812-lb. bluefin. Fishing is done with 200-lb. test spectra and 200-lb. flouro leaders.

The next day his line went tight about 2:00 pm and he has a fish that weighed out at 925 lbs. These fish were gutted and dressed out and sent off to the Tokyo fish market. Truly a catch of a lifetime.

The IGFA lists the all time blue fin tuna record caught on hook and line at 1496 lbs. The west coast blue fin record is at 243-lbs.

MEMO RE: **OCEAN ACCESS PROTECTION FUND**
 FROM: ENVIRONMENTAL COMMITTEE, LARRC (10-19-10)

The original law concerning our inshore fisheries was passed in 1999. Due to the lack of funds no implementation of this MLPA (Marine Life Protection Act) commenced for two years.

Since then hearings have been held under the aegis of the Blue Ribbon Task Force (BRTF) an appointed body. The central coast area has seen closures of about 18% after the conclusion of the process there. The northern coast is currently facing similar restrictions.

The South Coast process has gone on for almost two years and a conclusion is scheduled by the end of 2010. The BRTF, as we have learned, has had a strong bias for more extreme closures. The recreational community, although represented by a number of stakeholder representatives during the process, has long felt the results of a non-level playing field.

There is the onerous Memorandum of Understanding, into which the State entered, to have funding for the process. There is the reputed engagement of officials known to be allied with NGO's (non-government organizations). There are the involvements of major funds dedicated to the "preservation" of the oceans. During the North Central Coast process, the Governor fired then Commission President Cindy Gustafson because she would have sided with the fishermen's proposal 2XA. Don Benninghoven was appointed and quickly voted for a more restrictive alternate. Political maneuvering all around!

Recreational fishermen representatives, seeking to minimize coming restrictions, offered compromises that were completely overruled. Like a roller coaster, recent hearings saw the dismissal of one commission member after only eighteen days on the job. His replacement, a more "pliable" voter, cast a nay vote after his last minute appointment. The nay vote was about a request for a 45-day extension to give us time to study the details of the environmental conclusions particularly those recommended by the scientists/fish biologists involved. An extension of only 15 days was granted.

Running out of time the Department of Fish & Game (DFG) decided to go forward with a plan for the South Coast which was arrived at behind closed doors at the last minute. This plan is to be voted on at the final meeting on **December 15th**.

May of this year saw the filing of a lawsuit, by a prestigious California law firm. It was filed in order to give the recreational community access to the background documents used in arriving at the decisions to create a new array of marine protected areas along the Southern California coast. On October 1, Judge Patrick Marlette ruled that indeed public access to the BRTF and Fish & Game Decisions should be guaranteed since both entities are State agencies.

Thus their decisions must be part of the public records.

United Anglers of Southern California has spearheaded this suit. Former DFG Deputy Director, Bob Fletcher provided the lead. He's also the former head of SAC (Sportsfishing Assn. of California) The Partnership for Sustainable Oceans (PSO) is supporting this action. Members of PSO include American Sportfishing Association, Avalon Tuna Club, Coastside Fishing Club, IGFA, SAC and a number of other organizations.

October 6 saw a donation of \$10,000 by the Central Coast Fisheries Coalition. October 18 saw a donation of \$5000 by Los Angeles Rod & Reel Club. No doubt there are others but we recognize that this move may finally stall the roller coaster, hopefully for very long.

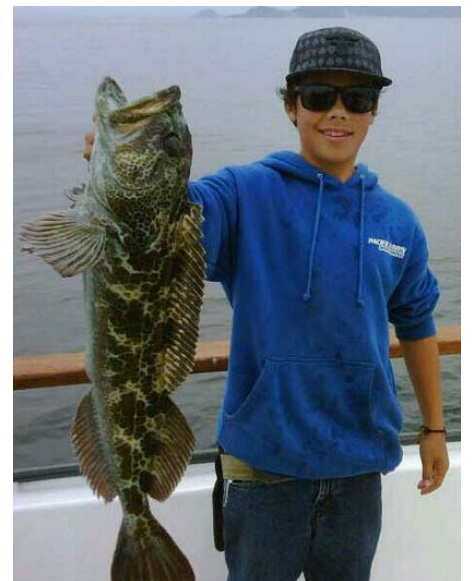

Charter Master Nick Ekdahl and anglers Frank Polak, Stan Richstone, Jim & Nick O'Donnell and Jim's friend Keith (a potential new member) boarded Capt Gary Lacroix's *Highliner* at 5 a.m. on Saturday morning at Redondo Sports Fishing. It was dark, overcast and drizzling but spirits were high. Gary and deckhand TC had gone out Thursday night and made live squid for our trip, we were looking forward to putting them to good use! Gary gave us the rundown of what had been happening in local waters lately and so the decision was made to fish locally. After the safety talk and making sure we all had our licenses, Gary headed us down around the corner to a reef in front of the old Marineland. We

were hoping for elusive white sea bass and the glamorous yellow tail with our candy bait. We got biters but it was mostly various bottom grabbers. Keith thrilled us momentarily when he hooked up with a big fish that grew wings and turned into a grumpy bat ray. As the sun came up the drizzle went away and it developed into a beautiful day on the water. We made our way to Rocky Point and a couple of other local spots. Young Nick O'Donnell was the hot stick as he caught not one but two trophy sheephead. Stan Richstone landed a nice legal ling cod which young Nick followed up with his own trophy ling cod! The rest of us caught

some nice-sized calicos, smallish barracuda and various bottom dwellers; the surface action was some of the best I have seen or heard about this season. I did hook a large fish that acted at first like a white sea bass, then like a yellow tail. Twenty minutes later a tail hooked 50# (estimated) black sea bass appears and it is a real beauty. It really fooled us. We got it unhooked and he went back down a couple of minutes later. Gary and TC did their usual outstanding job of finding the fish for us. We all had a fun trip, the fishing and company were great and the weather cooperated as well. ■

GER STEINBERG'S ODYSSEY ABOARD THE EXCEL

What a great trip to Alijos Rocks and the islands Oct. 10-17th. The water was flat, calm and greasy smooth—going and coming. We stopped at Cedros Island on the way down and all the players limited out on yellowtail in whatever way you like to fish for them. Then we took a peek at the lower banks for big tuna and wahoo but didn't luck out. By this time some of the shorter trip boats had left the "rocks" so we overnighted up to the rocks where two other

boats were already anchored, but Justin, the skipper, slid over to the opposite side of the rocks where we started to hook up 80- to 100-lb. tuna on the long soak. The fish were spooked, but they boiled constantly all

around us for several days in a row with always at least one or more hookups going from morning to late afternoon. During those three days of fishing I hooked and landed well over a dozen 80- to 110-lb. fish. The weather was high clouds and spotty sun, the seas calm and plenty of room on the stern rail because of the very light load. The only thing missing was the wahoo. We only scratched up two on the troll for the boat. Fortunately one was donated to the galley where the food was Jason's outstanding quality with custom preferences to everyone's liking. There was plenty of tuna for the galley with the usual sushi/sashimi spread for everyone.

The fall is an excellent time to fish these larger tuna and yellowtail with such light loads on all the long range boats, so visit your tackle store and treat yourself to one of the new lighter reels and go have a ball. ■

Earl Warren Addresses the Fish & Game Commission


On Oct. 20th I appeared before the Fish & Game Commission on behalf of LARRC and other organizations. The sole purpose of the meeting was to hear testimony on the draft environmental impact report (EIR) for the MLPA covering the south coast. There were over 800 in attendance evenly divided between fish and conservation organizations. Over 400 school children were bussed in to support the conservationists. I gave a very well-received, impassioned presentation that concluded by stating that the entire MLPA process and any action by the Commission to approve the MLPA for the South Coast at its meeting in December in Santa Barbara was tainted and unconstitutional. The recent ruling by a Sacramento Superior Court Judge in Fletcher vs. the Blue Ribbon Task Force, supports this claim. The task force and the Science Advisory Team violated most the laws of the State in regard to their refusal to deliver documents and information to the public claiming they are not "State Agencies". The court ruling held to the contrary and noted that both the task force and the team are state agencies and are required to deliver documents which they have not done to date.

This ruling, which is not final and probably will be appealed by the State, is the best shot we have at getting the process for approval of the EIR and MLPA stopped before the Commission makes its final decision. Because the term of Commissioner Rogers (a solid yes vote for the MLPA process) ends in January of 2011, the Governor and fanatical conservationists are pushing very hard to get the MLPA passed by the Commission before Rogers is

replaced.

I have it on very good authority that if Jerry Brown (whether you like him or intend to vote for him or not) has made a commitment to immediately appoint a pro-fishing person to the Commission which would be the swing vote to hopefully approve the Group 2 (Fishermen's proposal drafted by Merit McCrea). ■

SEINERS VS. SPORTFISHERMEN!

A recent article in *Sport Fishing* magazine addressed the purse sein activities taking place off the central american republics. In recent times the seiners have harassed sport fishing boats by surrounding them with nets or using their helicopter spotters to throw explosive devices. It was pointed out that recreational fishing provides considerably more revenue for the countries involved than does the commercial fisheries. Panama has become the first of the seven nations to ban purse seining. The effort underlines the movement toward sustainable fisheries.

In the past two years 10 recreational fishing vessels have been attacked off Costa Rica. The Billfish Foundation (TBF) urges travelers to do their fishing in waters of nations supporting the sustainability objectives.

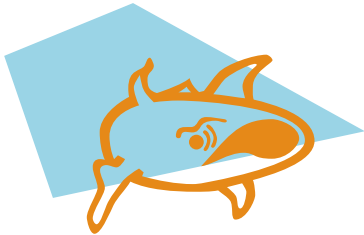

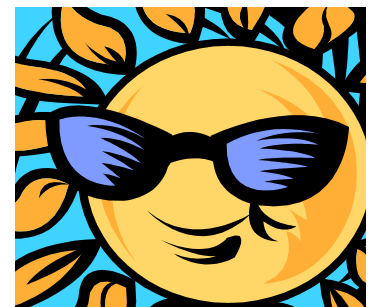

FOUNDATION ACTIVITIES

The LARRC Foundation has announced its grants for the year 2010. Three major efforts were decided upon following the guidelines established many years ago. These are mainly to promote the long term objectives of recreational anglers but also to enhance the awareness and importance of maintaining fishery stocks. Also the foundation has a goal to introduce economically disadvantaged kids to the sport and underwrites efforts to expose kids with disabilities to such activities.

You can read more about your foundation by consulting pages 38-41 in your year book.

A grant was made to several undergraduates at Cal State Long Beach University, Dept. of Marine Biology. Two graduate students and two undergraduates received a total of \$6500.

The National Coalition for Marine Conservation received a grant of

\$2500. Application for a total of \$5000 was made last year because NCMC was instrumental, among other projects, in fighting the excessive harvesting of forage fish in our oceans. Forage fish are sardines, anchovies, squid, mackerel etc. and are often used in poultry and pig farming. An initial grant of \$2500 was made in 2009.

A third grant was made to the Long Beach Aquarium. The \$7500 award will be used to study the effect of Humboldt squid on our sea life. The aquarium has also been helpful in entertaining the kids during our annual July Kids' Trip out of Pierpont Landing in Long Beach.

Kudos to the Foundation members (**Chas. Schoemaker, John Ballotti, Will Ebersman, Dave Levinson, Marvin C. Smith, Paul Varenchik, and head honcho Steve Simon**) for their fundraising and good deeds.

For the diehard fisherman, you can have your lunch delivered to your boat and get comfort knowing your boat is available from dawn (6am) to dusk (10pm). Your room has two complete en-suite facilities, and the lodge provides warm pants and jackets, boots and rain gear. Tackle and bait are provided as well.

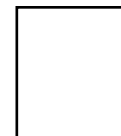
